As a nationally accredited IRS 501(c)(3) non-profit land trust organization based in Buck Hill Falls, PA, we are dedicated to preserving and protecting natural resources and wildlife habitats. Our mission is to achieve conservation goals through land and easement acquisition, habitat restoration, and environmental education programs. With a strong commitment to sustainability and community engagement, we play a vital role in preserving the natural beauty and ecological balance of Northeastern Pennsylvania.

# **STEWARDSHIP**


### **Year Overview**

In 2024, our conservation efforts prioritized the treatment of Eastern Hemlocks, a vital species for stream health and wildlife. With nearly half of the hemlocks along Buck Hill Creek severely affected by the invasive Woolly Adelgid, we expanded our Hemlock Conservation Project to include 1,650 trees in our database and treated over 600 with insecticide. Encouraging results have already emerged, reinforcing our long-term commitment to hemlock recovery.

Our forest restoration and wildlife management efforts also advanced significantly. We expanded our restoration work to 70 acres on Chestnut Mountain, planted 150 native saplings, and cleared over 150 acres of invasive plants. We addressed severe deer overpopulation in partnership with USDA Wildlife Services and installed deer fencing to protect a sensitive forest area.

The Foundation also recently marked a major milestone with the acquisition of a 688-acre conservation easement, expanding our protected land to 1,712 acres and linking a 6,600-acre watershed corridor.

The Foundation remained financially strong during the fiscal year ending December 31, 2024. We ended the year with total cash and short-term investments that covered 1.4 times total cash expenditures for the year. Most of the Foundation's expenditures funded stewardship activities, Inn Site swap transaction costs, and community engagement, including the community garden maintenance, educational hikes and our successful inaugural music concert.



# **Current Projects**



#### **Hemlock Conservation**

Hemlocks are crucial for riparian habitats, affecting stream quality and conditions while supporting diverse flora and fauna. Sadly, about half of the hemlocks along Buck Hill Creek are in critical condition due to an attack by the invasive Woolly Adelgid insect, and many have already died. To help save the remaining trees, we have expanded our Hemlock Conservation Project from Jenkins Woods into the Metzgars easement, adding 580 hemlocks for a total of 1,650 trees in our database. We have already treated over 600 large trees with an insecticide recommended by the PA Bureau of Forestry. Although treating all the trees will take over 4 years due to acreage limits, we are already seeing positive results from those treated in 2024.

#### **Dynamic Forest Restoration**

Our Dynamic Forest Restoration initiative aims to improve forest tree age diversity and health, thereby increasing its value as a wildlife habitat. In 2023, we undertook low shade removal of beech brush on a 60-acre parcel at Shaffer's Knob. This was followed in 2024 by similar efforts on a 70-acre block at Chestnut Mountain. Our method includes creating slash piles around valuable trees to protect their seeds and saplings from deer, aiding reforestation. This project has received funding through grants from the National Fish and Wildlife Foundation.



#### **Invasive Remediation**

Many areas disturbed by past timber harvests now contain a matrix of invasive plants that crowd out the forest floor, adversely affecting regeneration. The Foundation successfully eradicated invasive plants on over 150 acres on Chestnut Mountain in 2024, and we're now focusing on the area surrounding Metzgar's Farm, which is currently overgrown with Japanese Barberry.

#### **Deer Management**

A recent survey conducted by USDA Wildlife Services has estimated that the current deer density in our area exceeds 160 deer per square mile, which is 16 times a healthy population balance. An overabundance of deer negatively affects forest health by consuming all new growth, leading to habitat degradation for themselves and other species. Regrettably, the deer impact around Buck Hill Falls has been rated as "Too High" and is deteriorating further;



this impact is particularly evident along the deer fence in Jenkins Woods. The deer also carry ticks that spread Lyme disease.

Restoring a healthy balance allows both deer and forest ecosystems to thrive. The most effective method for managing deer overpopulation is lethal removal which, combined with safe processing, helps to address poverty-related hunger. Accordingly, the Foundation collaborated with USDA Wildlife Services to harvest 64 deer over 4 nights this winter, resulting in the distribution of nearly 8,300 meals to local food banks. Our Foundation will continue monitoring the health of the forest understory to evaluate the effectiveness of this program over time.



#### Reforestation

To enhance forest regeneration affected by invasive species and deer over-browsing, our Reforestation Project focuses on planting and protecting desirable native tree saplings. In 2024, we successfully planted 150 protected saplings, including blight-resistant chestnuts, on Chestnut Mountain. Additionally, we have constructed an 800-foot deer fence to protect a sensitive acre within Hemlock Cathedral. In 2025, we have already planted over 100 hemlocks and reintroduced 25 chestnut trees to Chestnut Mt., and we plan to continue planting in the fall to help restore the riparian buffer zone between Buck Hill and Griscom Creeks in Jenkins Woods.





# **Inn Site Land Swap Complete!**

In January 2025, our Foundation achieved a significant milestone by completing an exchange of the Inn Site property for a 688-acre Metzgars Conservation Easement on Buck Hill Falls Company land.

This exchange is a win for the Foundation, the Company, and our community:

- The Foundation furthers its mission by increasing the land it protects in perpetuity by two-thirds, to 1,712 acres. Additionally, we have already begun working on forest management plans to promote the health of the new conservation easement land.
- The Company regains ownership of the Inn Site, while continuing to own the easement property and retaining current passive recreational uses.
- This conservation easement has created a contiguous ~6,700-acre watershed conservation area for our community by establishing a key link between our Chestnut Mountain conservation area to the north and the State Game Lands to the south.



According to the Monroe County 2022 Return on Environment Study, large, forested areas such as this "provide significant natural system benefits: they help maintain healthy watersheds and water quality, filter air pollutants, moderate weather extremes, and provide important wildlife habitats."

Thanks to everyone involved in securing the Metzgars Conservation Easement, including our donors and the Open Space Institute's Delaware River Watershed Protection Fund, which is supported by the William Penn Foundation.










# New Trail Map with Metzgars Conservation Easement









# FINANCIAL OVERVIEW

### **Net Financial Position**




As of December 31, 2024, the Foundation held cash and short-term investments sufficient to cover 1.4 times the total cash expenses budgeted for 2025. The Foundation's short-term investments are held primarily in mutual funds. In the fiscal year ending December 31, 2024, the Inn Site property was written down by \$1.8MM to its sale value of \$1.1MM and reclassified from Fixed Net Assets to Net Assets Held for Sale.

### Revenues



In 2024, the Foundation generated cash revenue of \$310K net of payment costs. Total cash revenues (net of payment costs) increased by 26% from 2023 and were 6% below the budget for 2024. In December 2024, the Board of Trustees approved an annual budget that targets total revenue (net of payment costs) of \$329K in 2025. The 2025 budget implies a 6% increase in total revenue, driven primarily by our work to increase event ticket sales, grant awards, sponsorships, donations and memberships.

## **Expenditures**



In 2024, the Foundation incurred total cash expenditures of \$309K, including \$38K of non-recurring expenditures. Total cash expenditures increased by 6% from 2023 and were 5% below the budget for 2024. In December 2024, the Board of Trustees approved an annual budget that provides for total cash expenditures of \$329K in 2025. The 2025 budget includes \$20K of non-recurring transaction expenses and certain items that are contingent on achieving budgeted revenue increases.
